Rules and Regulations.

- The form must be signed by the present owner of the dog who should also obtain the signature of the previous owner. The declaration must be signed by all the owners in the case of a joint ownership.
- (3) No registered dog is eligible for entry in any show in the name of the **Transferee** until in the change in ownership has been duly registered with the Kennel club of India.
